

## Analysis Request Form – UMF Release Certificates

*This analysis request form should be used for all samples that require a UMF Release Certificate. For honey not requiring a release certificate, please use the general Analysis Request Form for honey.*

The UMF Honey Association (UMFHA) requires that all batches of final product requiring a UMF Release Certificate are compliant with the MPI Mānuka Honey Science Definition and meet the requirements of MPI classification of a monofloral mānuka. It is the licensee's responsibility to ensure that a batch has been tested using the MPI 5 Attributes and classifies as a monofloral mānuka when requesting a UMF Release Certificate.
